

Terms & Conditions for Maybank2u.com.sg Credit Card Promotion ("Promotion")

- Only new Maybank Credit Card applicants who apply for a Maybank Credit Card online and who do not hold any Maybank Credit Card(s) and/or have not cancelled their existing Maybank Credit Card(s) within six months prior to the start of this Promotion are eligible to the activation gift of S\$50 cash credit and a S\$20 CapitaVoucher ("Credit Card Activation Gift").
