- The Fund Transfer Programme is available to any Principal or Supplementary Cardmember (the "Cardmember") of a Visa or MasterCard Credit Card issued by Maybank (the "Card") whose card account ("Card Account") is in good standing as determined by Maybank.
- The Cardmember may apply for the outstanding balance(s) to be transferred (the "Fund Transfer") from any credit card or credit line account(s) held with any bank or financial institution in Singapore, other than Maybank, to the Card Account.
- The Cardmember is obliged to continue making payment to the credit card or credit line account(s) until he/she has received confirmation that the relevant account(s) has been successfully credited. Maybank shall not be liable for any overdue payment or interest incurred.
- The Fund Transfer amount(s) is capped at a maximum of 95% of your total available Credit Limit at the time of processing and Maybank has the absolute discretion to approve or decline any application and/or determines the approved Fund Transfer amount without giving any reason thereof, and Maybank's decision is final.
- tr'teats Points under the Maybank tr'teats Rewards Programme will not be awarded for Fund Transfer(s).
- Interest on the Fund Transfer(s) would be calculated on a daily basis, based on 365-day year unless otherwise stated or agreed to by Maybank. Interest is payable from the date Maybank approves the Fund Transfer application(s) until the date the Fund Transfer(s) is paid in full.
- Maybank reserves the right at its sole discretion to vary the interest rate chargeable and the basis of interest calculation at any time.
- The Cardmember authorizes Maybank to conduct credit checks and to obtain and/or verify any information about the Cardmember as Maybank in its absolute discretion deems fit.
- Late payment fee of 5% of minimum monthly repayment of S\$50, whichever is higher or such other fee as Maybank shall impose from time to time.
- A Fund Transfer Account will be opened for each successful Fund Transfer application and combined with the Card Account(s).
- The minimum monthly repayment for your Fund Transfer Account(s) that starts with 1155-XXXX-XXXX-XXXX or 1144-XXXX-XXXX-XXXX is 3% of the total payment due or S\$10, whichever is higher. The required minimum amount payable shall include any outstanding amount ("Past Due") from your previous statements.
- The Principal Cardmember shall be fully liable to Maybank for any and all amounts charged to and/or debited from the Fund Transfer Account(s) under his/her Card Account(s).
- The Credit Limit of the Cardmember's Card Account shall be reduced by an amount equivalent to the total outstanding balance in the Fund Transfer Account(s).
- Maybank reserves the right to terminate the Maybank Fund Transfer Programme and any Fund Transfer Account(s) without prior notice and without assigning reason therefore and the Cardmember shall forthwith on demand pay all monies owing under the affected Fund Transfer Account(s).
