**Terms and Conditions for Maybank Online Home Renovation Loan \$100 Rewards Campaign (“Campaign”)**

1. This Campaign is available from 1 November 2019 to 31 December 2019 (both dates inclusive), unless otherwise extended or otherwise terminated by Maybank in its sole discretion (the “Campaign Period”).
2. Maybank Home Renovation Loan (for payment of home renovation cost) (“Loan”) applicants (“Applicants”) are eligible to participate in the Campaign.
3. To be eligible to receive S\$100 worth of Takashimaya vouchers (“Gift”) under the Campaign, the Applicant must, during the Campaign Period, successfully apply for a Loan via the online loan application platform on Maybank’s website with a minimum loan quantum of S\$15,000 and a minimum loan tenure of three (3) years (“Loan”) (“Successful Applicant”).
